4-H Online Enrollment

Below are a few important enrollment dates to remember as we move into the 24-25 4-H year.

October 1- All 4-H members, Cloverbuds, and adult volunteers need to re-enroll in the 4-H program for the 2024-2025 year by logging into and updating their 4-H Online account. 4-H members will need to pay the annual enrollment fee of \$15. Follow this link to go directly to the 4-H Online website.

The glitches that occured in 4-H Online at the beginning of the 4-H year should now be fixed. Enrollment is open!!!*

November 30- Per the Wyandotte 4-H Fair Book on page 2 under the Exhibits section, rule #2 and on page 5 under the Livestock Auction section, Rule #1:

"Returning Wyandotte County 4-Hers are to be enrolled annually by Nov. 30 in order to be eligible to receive ribbon premiums and participate in the livestock auction as 4-Hers."

This rule will be enforced for the 2024-2025 4-H year.

The 4-H agent will run a report of enrolled 4-H members from 4-H Online the following business day after November 30. This report will be referenced when 4-H members are tagging in livestock projects and submitting livestock entries in the 2025 county and state fairs. Any returning 4-H members who enroll after the Nov 30 deadline will still be allowed to participate in 4-H club meetings and other 4-H events.

May 1, 2025- Will be the last day to enroll in 4-H Online and select projects for participation in the 4-H divisions at the county and state fair.

-Breeding/non-market livestock forms due to the 4-H agent

-**HORSE ID FORMS** All horse ID forms must be updated this year with the new 24/25 official form. The Wyandotte County 4-H deadline for these forms will be May 1, regardless of the state horse show's deadline.

June 15, 2025- Annual copy of Youth for the Quality Care of Animals (YQCA) certification for all 4-H members showing a livestock animal due to the 4-H agent.

48 Hours of 4-H Service Project

Shooting Sports

Anyone interested in joining or learning more about the 4-H shooting sports project is invited to attend a meeting on **November 3rd at 3pm.** The meeting will take place at Tri-County Rod & Gun Club 18573 Stillwell Rd, Linwood, KS 66052.

At this meeting, 4-Hers will get general information about the project and disciplines, meet other youth who participate in 4-H shooting sports, and meet the project leaders. Newly enrolled 4-Hers will get to participate in the first safety meeting. Returning 4-Hers will help with inventory, cleaning, and organizing. For returning 4-Hers who qualify there will be a "try it" session with pistol or air rifle.

The disciplines the Wyandotte 4-H Shooting Sports project will be able to provide for the 24-25 year are Air Pistol, Air Rifle, Archery, BB, Muzzleloader, Smallbore Pistol, and Smallbore Rifle.

This meeting will also recognize the accomplishments of the 23-24 4-H shooters, including presenting Archery state medals, announce 4-H Nationals qualifiers, state results, and more.

Districting information for Wyandotte and Leavenworth Counties

By now some of you have heard the rumors about Wyandotte and Leavenworth counties becoming an Extension District. Both counties, their respective governments, Extension staff, and Kansas State University are seriously exploring the option of districting. Below is information that should help answer questions about districting and how it will affect the 4-H program.

- -Each county will maintain their own respective 4-H programs and 4-H agents.
- -The function of the 4-H clubs and ability to attend 4-H events will not be affected by districting.
- -Enrollment and participation will continue as usual.
- **-Each county will keep their respective county fairs.** The county fair associations are responsible for hosting their individual county fair. Districting will not be the reason for any changes to the 4-H activities at the county fair.

History

- In 1991, the Kansas Extension District Law allowed local Extension Councils and county commissions to partner with one or more counties to form an Extension district. Once formed, the Extension district becomes a taxing subdivision of the State of Kansas and has the power to contract, acquire, hold, and convey real and personal property. An Extension district creates opportunities to structure an Extension unit to serve the needs of the residents in those counties. This framework creates more efficient, relevant, effective, and sustainable programs. In the last 33 years, 59 Kansas counties have formed into 21 Extension Districts.

-In 2009, Leavenworth and Wyandotte Counties started the process to become an Extension District. At that time, only the Wyandotte County Commissioners were willing to proceed and the idea was abandoned.

Why Explore Districting Now?

- -Leavenworth County Extension had a flat budget for the past four years, including fiscal year 2025.
- -This summer, Wyandotte County Extension received a budget cut of \$59,500 (10%).
- -With rising costs, Extension agents are not able to continue programming with limited or no funding.
- -Both county governments have asked Extension staff to find ways for cost savings in the 2026 budget cycle. County commissioners suggested the idea of forming an Extension District.

Some benefits of forming a district, as observed by the current 21 Extension Districts in Kansas:

Effectiveness: Districting allows for agents to become specialized in program areas. Specializing allows agents the ability to focus on specific program areas with additional resources and support from other staff members. Agents in an Extension district experience less burnout and are able to intentionally focus on expertise and subject matter.

Relevance: Districting helps Extension establish itself as a relevant resource for Kansas residents. We must ensure we are on the cutting edge in dealing with contemporary issues for the residents we serve. Residents expect more in-depth knowledge beyond the basics, and this framework allows for that specialty knowledge.

Efficiency: Merging operations can lead to financial efficiencies and free up more time for programming as both counties pool their resources.

Sustainability: Addressing the financial aspect of operations assures the sustainability of having K-State Research & Extension Programs in both counties. By establishing a taxing authority, the Extension District gains more flexibility to meet the needs of its personnel and operating needs and ensures continued programming.

Staffing: All staff will remain employed.
